### Legislative Update: House Bill 511

HB 511 increases the marriage age to 18, with an exception for persons age 17 who get judicial permission and are no more than 4 years younger than the person they seek to marry. The bill creates a 14-day waiting period after a 17-year-old files for judicial permission. Currently, girls under 16 may seek permission to marry if they are pregnant, regardless of the age difference between the parties. Therefore, the current law conflicts with Ohio's statutory rape laws, and leaves young girls vulnerable to forced marriages.

HB 511 passed the Ohio House unanimously on June 27th, and will be considered in the Senate when the General Session reconvenes after the summer break. Stay tuned for action alerts! Visit oaesv.org/public-policy for updates!
