## **Response to Title IX Changes**



OAESV knows first-hand that reasonable accommodations for survivors of sexual violence during and after investigations have allowed survivors all over Ohio to continue to pursue an education without fear of further sexual violence or harassment. In cases where Title IX has not been followed, survivors have suffered tremendously in pursuit of their degrees. Further, K-12 survivors, who must attend school each day by virtue of law, have no escape from school-based sexual harassment or violence if school personnel do not act.

It is critical that, despite the deep and frightening changes to Title IX, Ohio's educational institutions commit to protecting survivors and keeping their campuses safe. OAESV implores schools to continue recognizing scientific data on sexual violence and trauma, and support survivors in every possible way allowed under the law.

OAESV will push for changes during the Notice and Comment period, work with campuses to ensure survivors are protected, and support survivors in pursuit of safety and healing.
