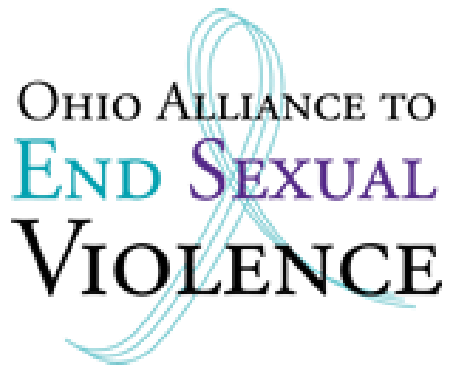

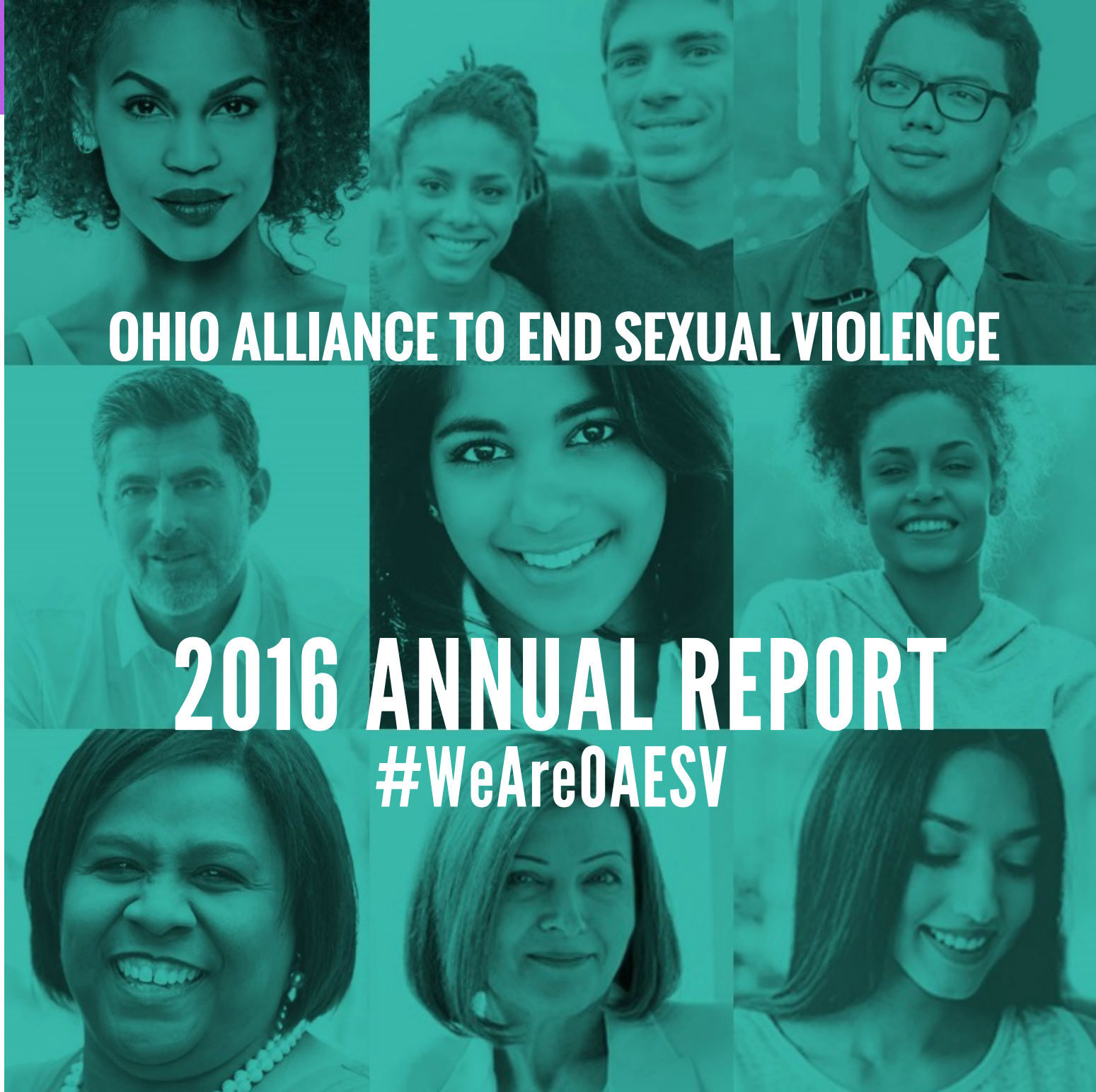

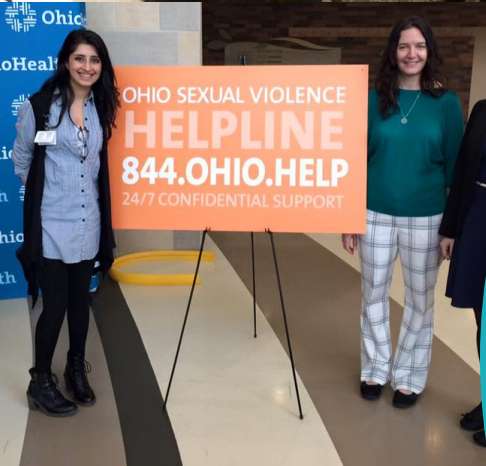

PUBLIC POLICY ADVOCACY

OAESV advocates for public policies that promote healing for survivors, accountability for offenders, and safety for Ohio's communities.

Public Policy Spotlight

House Bill 359, which went into effect on September 8, 2016, established an Address Confidentiality Program for eligible victims of sexual assault, domestic violence, stalking, and human trafficking that enables these victims to conceal their address from public view.

Advocacy Day

OAESV's Annual Advocacy Day to End Sexual Violence on May 11th was attended by 116 advocates, prevention specialists, and survivors from across Ohio.

Survivor Council

OAESV's Survivor Advisory Council is comprised of 13 adult survivors of sexual assault and child sexual abuse from across Ohio who inform OAESV's public policy priorities and participate in public policy advocacy.

Be The One

Be The One is a project of the Ohio Sexual and Intimate Partner Violence Prevention Consortium, and is an online program geared toward middle school and high school students designed to teach them how to recognize and prevent sexual violence. The "I Can Be The One" website, maintained by OAESV, contains videos, documents, and other resources for youth and adults.

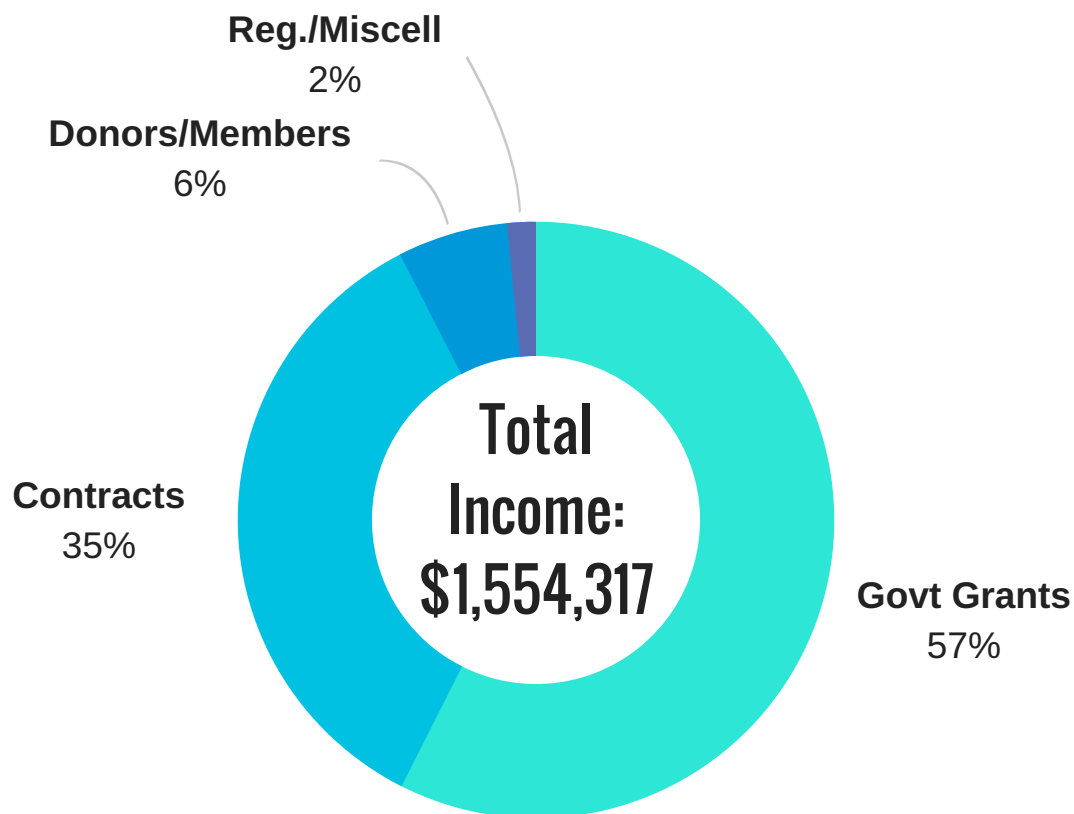

Changing Campus Culture

With funding from the Ohio Department of Higher Education, OAESV partnered with statewide and local partners to implement the Changing Campus Culture Initiative. The project included surveying Title IX Coordinators at 59 campuses, providing four regional trainings on prevention attended by representatives from 82 campuses, and providing four regional trainings on response attended by representatives from 74 campuses. The project also resulted in the development and publication of the "Transforming Ohio Campuses" toolkit, a comprehensive 162-page guide for campuses on implementing the Changing Campus Culture Initiative.

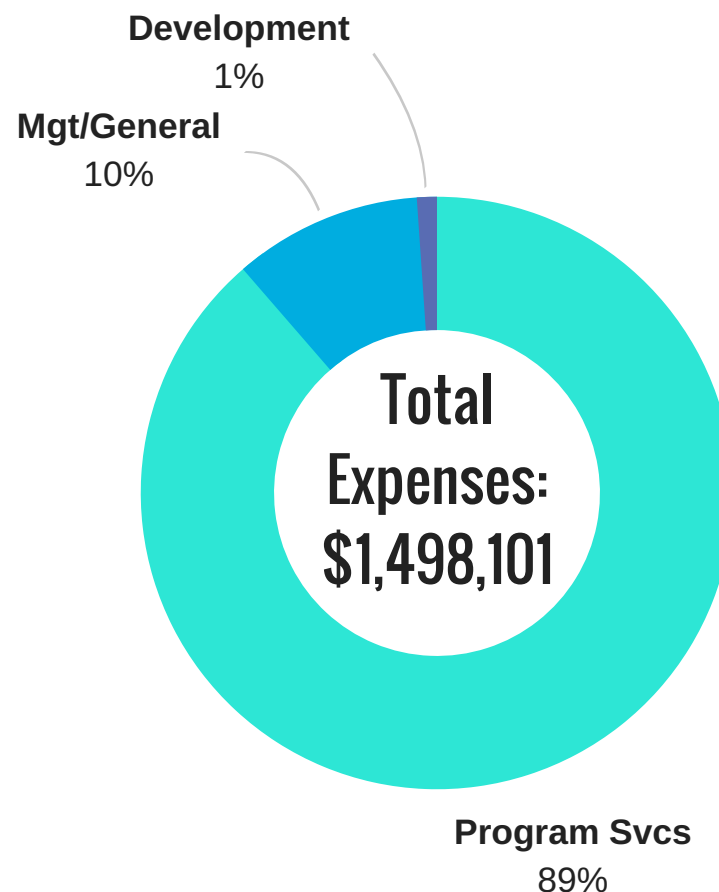
