Ohio Senate District 9 Counties: Hamilton (part) Senator Cecil Thomas was elected in November 2014 to serve Ohio's 9th Senate district, which includes parts of Cincinnati, St. Bernard, Elmwood Place, Norwood, Golf Manor, Hollydale, Columbia Township, Silverton and Springfield Township.

A product of a working class family, Senator Thomas was born in rural Alabama in 1952.

At the age of eight, his family moved to Cincinnati settling into the West End community where he attended St. Anthony Catholic School. After graduating from Withrow High School, he took a job as a public service worker. However, with the desire to attend college he joined the Cincinnati Police Cadet Program, which offered free college tuition.

Prep for Groups

Tips your group may find helpful:

- Designate roles
- Establish a plan
- Review any meeting notes that OAESV has provided to you



Communication & Meeting Tips

- Keep an eye on the time
- Don't worry about being an 'expert' on the legislative details
- Embrace your expertise & the perspective you bring to the issues on OAESV's Advocacy Day Agenda

Avoid bringing up other issues – that can be raised in a meeting outside of Advocacy Day!



Communication & Meeting Tips

- Questions from lawmakers may not align with the topic you are discussing
- Balance sharing information amongst your group mates Be aware of the privilege and power you are bringing into a space and make space for others to share



Effective Advocacy with Members

Trust and mutual respect are key components of effective advocacy

 Your individual politics or values may not align with your elected official's – even if you disagree with a member, you want them to view you as a trusted source of information


This is your opportunity to build a foundation for education

Navigating Unknowns

If you are meeting with a lawmaker that may bring up other legislation, we will do our best to notify you of that ahead and/or prepare your group lead.

It is always acceptable to note down a question or request that you will need to follow up on:

"That's a great question. I don't have that information, but we will make a note of it and follow up with your office."





Concluding Your Meetings



Check for questions



Express thanks for the meeting



If you discuss follow up information, reiterate that you will get back to them



Invite the legislator and/or staff to an upcoming event or to visit your program



Ask permission to take a photo AND share it social media

HB 89: Prohibit Intimate Exams on Unconcsious Patients



HB 143: Expand Housing Protections for Survivors



House Bill 161 – Spousal Rape Loophole

Title: Eliminate spousal exceptions for certain sex offenses

- Sponsors: Representative Miranda, Representative Hillyer
- Status: Passed Ohio House; Currently in Ohio Senate on Judiciary Committee
- What will it do?
 - Remove the spousal rape loophole from certain sex offenses
 - Permit spousal testimony in a prosecution of certain sex offenses



House Bill 89 – Prohibit Intimate Exams on Unconscious Patients

Title: Regards intimate examination of anesthetized, unconscious patient

- Sponsors: Representative Munira Abdullahi, Representative Hillyer
- Status: In Ohio House on Public Health Policy Committee
- What will it do?
 - Prohibit certain medical professionals and students from performing or authorizing another to perform intimate examinations on an anesthetized or unconscious patient
 - Intimate examination is defined as a rectal, prostate, or pelvic examination in the bill



House Bill 143 – Housing Protections for Survivors

Title: Enact the Ohio Safe Homes Act

- Sponsors: Representative Grim
- In Ohio House on House Criminal Justice Committee
- What will it do?
 - Protect survivors of domestic violence & sexual violence from "nuisance" related charges for service calls to law enforcement
 - Provide early lease termination avenue for survivors
 - Provide option for new lock/locks installation
 - Prohibit landlord from sharing address or identifying information



Framing the conversation

- Brief introductions
- State your purpose: "We are here for OAESV's advocacy day to end sexual violence, and we would like to discuss HB 143, sponsored by Rep. Grim, with you."
- · Ethical storytelling is encouraged
- Data can be shared as well
- Personalize the issues by talking about the needs you see in your local area

Preparation

- What you can do TODAY:
 - Start looking for connections between the highlighted bills for this Advocacy Day and your own area of practice, lived experience, or other expertise.
 - Prepare short talking points for each topic that you wish to speak about on OAESV's Advocacy Day agenda.
 - Research the lawmakers from your district.
