OAESV PROVIDES STATEWIDE LEADERSHIP, RESOURCES, AND SUPPORT TO ADDRESS AND PREVENT SEXUAL VIOLENCE IN OHIO. KEY ACCOMPLISHMENTS INCLUDE DELIVERING TRAINING AND CONSULTATION TO RAPE CRISIS CENTERS, ALLIED ORGANIZATIONS, AND COMMUNITY PARTNERS TO IMPROVE SURVIVOR SERVICES, ENHANCE PREVENTION EFFORTS, AND STRENGTHEN ORGANIZATIONAL CAPACITY. WE ENGAGED IN LEGISLATIVE AND POLICY INITIATIVES TO EXPAND RESOURCES, STRENGTHEN SURVIVOR PROTECTIONS, AND SHAPE PUBLIC POLICY THAT AFFECTS VICTIMS OF THE CRIME OF SEXUAL VIOLENCE. WE COORDINATED A PANEL OF QUALIFIED ATTORNEYS TO PROVIDE SURVIVORS WITH REDUCED-RATE LEGAL REPRESENTATION, INCREASING ACCESS TO JUSTICE AND ENSURING INFORMED DECISION-MAKING. OAESV ALSO DEVELOPED AND IMPLEMENTED STATEWIDE CAMPAIGNS AND EDUCATIONAL INITIATIVES TO INCREASE PUBLIC UNDERSTANDING

FVPSASA (FAMILY VIOLENCE PREVENTION AND SERVICES ACT SEXUAL ASSAULT, AMERICAN RESCUE PLAN ACT, DEPARTMENT OF HEALTH & HUMAN SERVICES) - SUPPORTING AND EXPANDING SEXUAL ASSAULT SERVICES DURING COVID. (FAMILY VIOLENCE PREVENTION AND SERVICES ACT) THIS PROGRAM SUPPORT TO ALL OHIO RAPE CRISIS CENTERS FOR COVID SUPPLIES AND SELF CARE. THIS WAS THE FIRST TIME IN HISTORY THAT SEXUAL ASSAULT PROGRAMS RECEIVED FVPSASA FUNDING THROUGH THE AMERICAN RESCUE PLAN ACT (ARPA) VIA THE U.S. DEPARTMENT OF HEALTH & HUMAN SERVICES. THE FUNDING RECOGNIZED THAT SURVIVORS OF SEXUAL VIOLENCE WERE SIGNIFICANTLY

OAESV OFFERS SPECIALIZED TRAINING PROGRAMS DESIGNED TO STRENGTHEN OHIO'S RESPONSE TO SEXUAL VIOLENCE, FOCUSING ON TRAUMA-INFORMED CARE, LEGAL ADVOCACY, CRISIS INTERVENTION, AND SERVICES TAILORED TO MEET THE NEEDS OF DIVERSE COMMUNITIES. IN ADDITION TO TRAINING, OAESV PROVIDES TECHNICAL ASSISTANCE TO MEMBER PROGRAMS AND PARTNERS, OFFERING GUIDANCE ON POLICY IMPLEMENTATION, PROGRAM MANAGEMENT, AND COMPLIANCE WITH STATE AND FEDERAL REGULATIONS, ENSURING A CONSISTENT, EFFECTIVE, AND SURVIVOR-CENTERED SERVICE FRAMEWORK ACROSS OHIO. WHILE PRIMARILY FOCUSED ON PROGRAMMATIC SERVICES, CERTAIN FUNDS ALSO SUPPORT ESSENTIAL OPERATIONAL NEEDS UNLESS SPECIFICALLY RESTRICTEDSUCH AS MAINTAINING OFFICE INFRASTRUCTURE, TECHNOLOGY SYSTEMS, ADMINISTRATIVE SUPPORT, AND OTHER CRITICAL RESOURCES.
