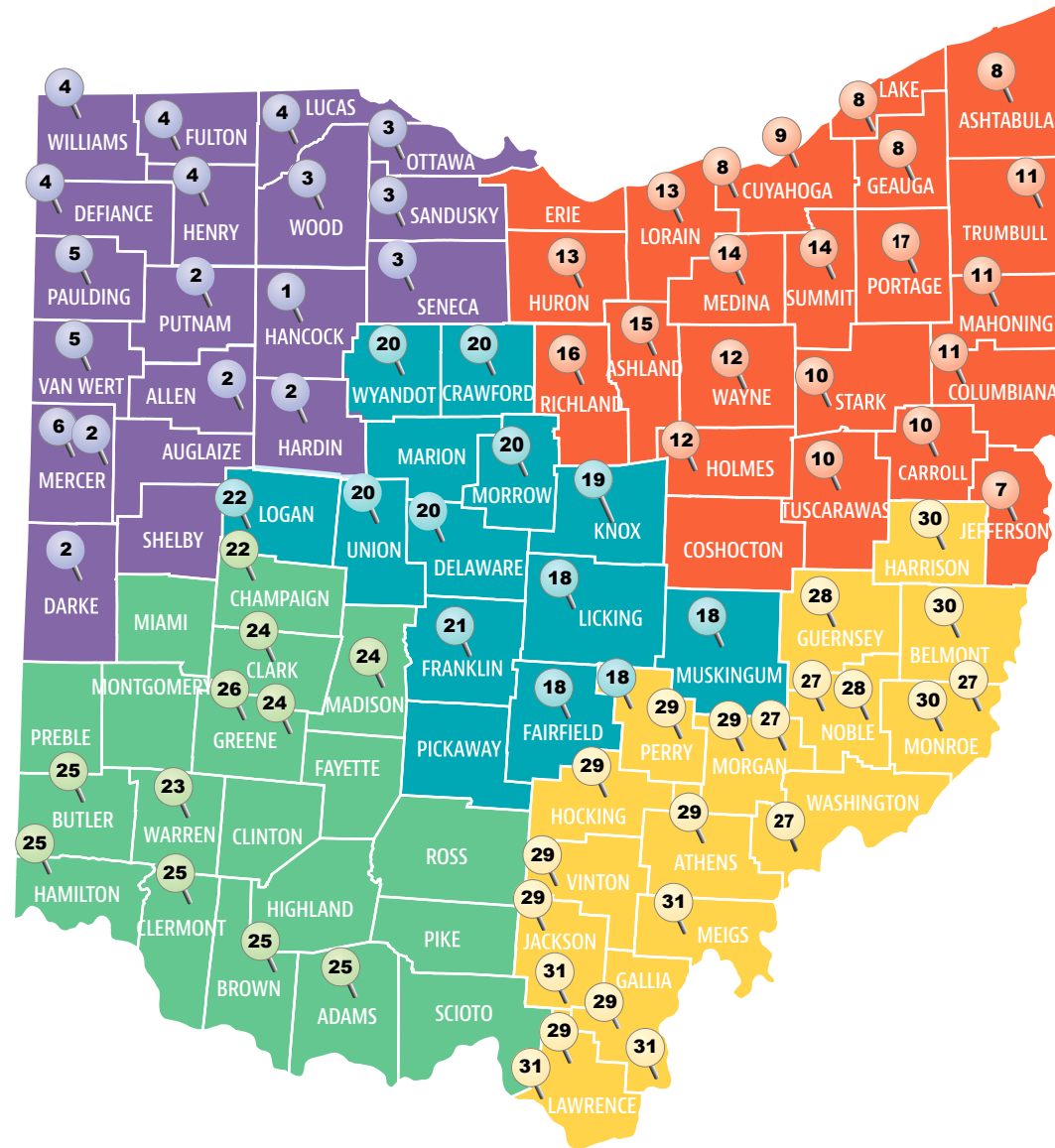

Dear Survivors, Allies, Advocates, and Change-Makers,

2025 was a year of Voices of Change.

Not the kind of change that is comfortable—but the kind that is courageous. Across our nation, communities carried deep fatigue, uncertainty, and division. Systems felt strained. The nonprofit sector continued to face shifting priorities and real resource challenges. Yet even in the midst of all that, one truth remained: **survivors still needed us.**

Survivors needed safety.
Survivors needed advocacy.
Survivors needed systems that respond with dignity, not doubt.
Survivors still needed people who would show up—again and again—with integrity and love.

At OAESV, we did not allow the climate of 2025 to shift our identity or soften our conviction. We stayed grounded in our mission and guided by survivors. 2025 Impact Highlights

The work we do is not symbolic. It is not theoretical. It is not performative.
It is real.
It is measurable.
It is life-changing.

This year, OAESV strengthened the statewide movement through coalition leadership, training, prevention, technical assistance, and systems improvement. Together, we achieved:

- **102 trainings and events** delivered across Ohio
- **195 technical assistance engagements** supporting and strengthening local programs
- **109 resources published** to equip the field with survivor-centered tools and guidance
- **581 meetings to improve systems**—because real change happens where decisions are made
- **175 attendees at Annual Conference**, expanding learning and strengthening statewide collaboration
- **357 attendees at Advocacy Day**, demonstrating power, unity, and commitment to survivors

Behind every number is a person, a story, a moment of courage, a program, and a community moving closer to safety and accountability. This is what Voices of Change looks like: **consistent action, survivor-centered practice, and collective courage.**

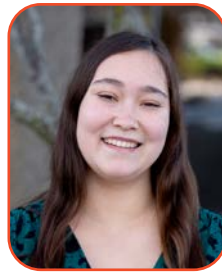

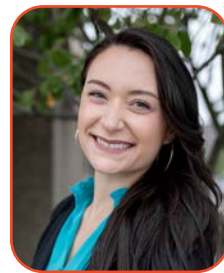

Meetings, Collaboration, & Field Improvement

In 2025, OAESV held regular meetings and supported collaborative efforts that brought partners together to strengthen coordination and improve the effectiveness of anti-sexual violence efforts across Ohio. These activities supported information-sharing, alignment across systems, and collaborative problem-solving, contributing to stronger and more responsive services statewide.

Meetings and collaborative activities included leadership meetings, policy-focused calls, campus-based collaboration, coordinated community response meetings, project-specific interagency discussions, and working groups focused on addressing service challenges and identifying practical improvements.

In addition to ongoing meetings, collaborative efforts in 2025 supported shared learning and capacity-building through training and professional development activities, research-informed projects drawing on field data and practitioner input, peer networking and coordination, and strategic reactivation of collaborative efforts to strengthen engagement and effectiveness.

Participants represented a broad cross-section of the field, including sexual violence programs, educational institutions, law enforcement, social workers, state and national coalitions, advocacy organizations, government agencies, interagency working groups, and sexual assault forensic nurse examiners.



In total, OAESV Convened 581 Meetings

in 2025 to support system coordination and strengthen responses to sexual violence across Ohio.

CCRT/SART-Focused Initiatives

In 2025, OAESV supported Sexual Assault Response Teams (SARTs) and Coordinated Community Response Teams (CCRTs) across Ohio through sustained collaboration, training, and technical assistance. This work focused on strengthening coordination among multidisciplinary partners, supporting consistent application of best practices, and responding to emerging needs across local communities.

OAESV facilitated monthly statewide collaboration meetings that brought together SART partners and forensic nursing professionals to strengthen connection, share expertise, and support peer learning. These meetings included the development of a mentorship model for forensic nurses to support professional growth, knowledge-sharing, and continuity of practice across the state.

To support law enforcement and multidisciplinary partners, OAESV published and distributed 18 new sexual assault kit (SA Kit) resources statewide, providing materials to every law enforcement agency in Ohio – nearly 1,000 agencies. Recipients reported strong demand for these tools, with many requesting additional copies for broader distribution. The SA Kit resources included multilingual materials on evidence timelines and kit tracking, a comprehensive investigation resource guide with checklists, recorded webinars, and supplemental trauma-informed resources designed to support effective and survivor-centered response.

In addition, OAESV expanded access to professional learning by providing a webinar subscription to law enforcement agencies throughout the state for End Violence Against Women International. OAESV also coordinated peer-to-peer law enforcement training and technical assistance, and responded to SART partner requests related to training, public awareness, and various individualized needs.

Throughout the year, OAESV advanced efforts to update Ohio's statewide SART model—last revised in 2014—to reflect current best practices, incorporate practical tools and templates, highlight effective local approaches, and expand guidance for team development and collaboration. OAESV also convened timely connection spaces during periods of uncertainty to support communication, problem-solving, and continuity across teams.

MEMBER-FOCUSED ENGAGEMENT & SUPPORT

Program Visits

As the statewide coalition, OAESV maintains the Core Standards, which is a document that outlines the service standards for rape crisis services and prevention in Ohio. Every two years, OAESV conducts in-person program visits to current Qualified Ohio Rape Crisis Centers to evaluate how well these centers implement the Core Standards, to build relationships, and identify training needs. This process helps determine which programs deliver strong services or need more support and highlights regional gaps. These standards also inform whether a program is ready to become a new or developing Qualified Ohio Rape Crisis Center and is eligible to apply for Ohio Rape Crisis Trust Funding.

In 2025, our staff traveled over **10,000 miles across Ohio** to complete program visits

Feedback from this year's program visits was overwhelmingly positive, providing valuable insights into the needs of sexual assault advocates and survivors. The collected data will inform future training and technical assistance initiatives, with a specific focus on enhancing accessibility and sustainability across dual programs, thereby ensuring trauma-informed care for all survivors.

This year's outcomes:

- OAESV provided **31** Program Visits with Qualified Ohio Rape Crisis Centers and 1 visit with a new/developing rape crisis center (two additional visits took place in December 2024)
- **6** programs exceeded standards
- **21** programs met standards
- **4** programs were approaching standards

Program strengths:

- Survivor-centered programs with an emphasis on trauma-informed services
- Creative solutions to reduce barriers for survivors accessing services
- High commitment to community coordination and collaboration
- Community outreach and strong partnerships to increase awareness

Focus areas to increase the effectiveness of rape crisis services in Ohio:

- Increasing cultural responsiveness
- Enhancing accessibility
- Strengthening sexual violence services at dual programs
- Enhancing systems-based advocacy
- Increasing statewide capacity for prevention programming

Additionally, OAESV has reached out to counties lacking sexual assault services to assess potential providers. This year, OAESV visited two newly established Qualified Ohio Rape Crisis Centers and engaged a domestic violence program to develop a sexual assault-specific hotline and advocacy services. Through these efforts, OAESV has maintained and expanded sexual assault services statewide.

Professional Development Scholarships

over **159** scholarships provided nearly **\$200,000** in monetary support to **over 5** events including:

Collective Calls

Collective Calls are monthly gatherings that strengthen connection, shared learning, and community among those working to end sexual violence across Ohio. With a rotating focus, these sessions support members and other partners through skill-building, peer exchange, and opportunities to connect across roles and regions.

Collective Calls include:

In-Service Trainings

Members-only skill-building sessions focused on emerging practices and shared learning.

Program Spotlights

Peer learning spaces where member programs share projects and receive feedback.

Connection Spaces

Open, facilitated conversations that build community across roles and regions.

Technical Assistance

We are committed to providing consistent, best-practice responses to sexual violence and supporting survivors through high-quality care. It is both our privilege and responsibility to offer technical assistance to our members. Whether through email or in person at one of the state's rape crisis centers, OAESV staff worked closely with programs to overcome specific challenges, all with the goal of enhancing services for survivors and the communities served.

Every year, we provide trainings and events for victim service professionals, allied professionals, and the public on a wide range of topics related to the prevention of and response to sexual violence. Our offerings are relevant, forward-thinking, timely, and focused on centering the voices and lived experiences of survivors in Ohio.

Self-Care Retreat

Gathering Power. Summoning Care.

This work is both deeply meaningful and deeply demanding. This retreat created space for collective healing. Over two days, advocates gathered to rest, reconnect, and remind one another that we are not alone in this movement.

In 2025, OAESV collaborated with other organizations across the state to support leadership development within Ohio's anti-violence field. These collaborations were an investment in connection, collaboration, and professional growth. Through coordinated learning opportunities and peer engagement, participants strengthened leadership skills, expanded professional networks, and enhanced their capacity to support survivors and communities.

At a 2025 leadership development summit, **From Connection to Leadership**, excellence and innovation within the movement were highlighted. **Jazmin Vera** was named the **2025 Rising Star** for her leadership in advancing statewide housing initiatives at OAESV, expanding access to trauma-informed services for survivors across Ohio. **Audrey Walker** received the **Malina L. Gavins Award** in recognition of her long-standing commitment and sustained service to the anti-violence field.

Affirming Advocacy – Embracing Care for All provided participants with comprehensive and innovative strategies for advocacy, outreach, and survivor empowerment, particularly in communities and organizations that are often underserved. The training emphasized adaptable, survivor-centered approaches that enhance access to services, promote safety, and support effective responses across diverse community contexts.



In 2025, our Annual Conference was an integral part of our Voices of Change campaign—a yearlong initiative to uplift survivors, strengthen collaboration, and drive meaningful action. Our conference emphasizes the strength and unity found in collaboration and collective action. It provided a dedicated space to speak up and take actionable steps in our communities to create safer, more supportive spaces for survivors and to end sexual violence at its roots. ANNUAL CONFERENCE

PREVENTION & PUBLIC HEALTH



Prevention 201 Immersion: was an in-depth, two-day training designed to elevate the understanding and application of 201 level prevention strategies. These trainings were built upon the foundational knowledge of primary prevention and introduced topics that can be used as we enter into a modern era of prevention. This was in person, which also provided opportunities to be in community with other prevention practitioners across the state, with rest and play integrated. This was a Members Only opportunity.

DATA COLLECTION SYSTEM PROJECT PHASE TWO

In 2024, OAESV launched a comprehensive multi-phase initiative to transform how rape crisis centers across Ohio collect, manage, and report data about sexual violence. This ambitious project recognizes that better data leads to improved services for survivors and stronger advocacy for systemic change.

Phase One:

- Held listening sessions with Ohio rape crisis centers, funders, and survivors to inform the project
- Researched software options and a cost-benefit analysis of solutions to improve data collection
- Created a centralized location for sexual violence services data
- Generate statewide reports

Moving forward, OAESV will concentrate on increasing the capacity of Ohio rape crisis centers to improve their sexual violence data collection. OAESV plans to use an annual survey to gather Ohio sexual violence data, rather than aiming to onboard all RCCs to one singular tool like Vela Direct. The goal is to create annual reports with aggregated data that shows the number of survivors served by Ohio rape crisis centers. This data will inform statewide public policy and funding advocacy work while helping Ohio rape crisis centers.

Phase Two: implementation and testing of the project's vision.

Beginning in early 2025, OAESV and three Ohio rape crisis centers agreed to pilot Vela Direct for six months.

- OAESV introduced and conducted demonstrations of Vela Direct to Ohio rape crisis centers.
- OAESV covered the upfront costs and the first year's costs of the pilot, provided supportive onboarding training with Vela, and hosted monthly office hours for ongoing support.
- Ubuntu Research & Evaluation conducted interviews with programs after six months to assess the impact of the software on sexual violence data collection.



ADVOCACY SERVICES & ENGAGEMENT WITH SURVIVORS

OAESV provides many services directly to survivors. These include emotional support, providing information about local services, court accompaniment, housing support, and more.

- In 2025, we added 5 new members to our Survivor Empowerment Advisory Council. They spoke at a panel during our Annual Conference; presented at our bi-annual Training Institute for Advocates; created a fact sheet on securing mental health providers; attended a listening session with OCJS to inform the STOP/VAWA implementation plan for Ohio; and more.

71 survivors served through our advocacy program with **310** hours of direct service

- Rachel Ramirez (ODVN) and OAESV's Survivor Coordinator Shelby Lieber presented on strangulation and traumatic brain injury for the U.S. Navy

- We continued our Survivor Storytelling project, officially launching the stories for advocate-use in a trauma-informed, survivor-centered way. In collaboration with OAESV and the storytellers, Dr. Ngozi Oparah created a discussion guide to go along with the stories. The guide will launch in 2026.

LEGAL SERVICES

The **OAESV Legal Clinic** is proud to stand as Ohio's only legal services provider dedicated solely to protecting the rights of survivors of sexual violence.

(A few of our) 2025 Highlights:

The Legal Team...

- provided criminal justice advocacy for a survivor who had been waiting for three years for her case to finally come to trial. She now works for a law firm in Columbus that specializes in providing civil representation to other survivors, and she's thinking about going to law school.
- helped a teen survivor change her last name and be adopted, giving her a life-long tie to a caring and supportive father.
- used a relatively new law that allows human trafficking survivors to get a fresh start. Over the course of seven months and three different trials, the team was successful. The survivor now works as a full-time advocate, helping others struggling with addiction and speaking to school groups throughout the state.

Attorneys Caitlyn Benzo and Stephanie Scalise became founding members of the Ohio Victim Services Bar Association, creating a statewide professional organization dedicated to mentoring new lawyers to provide services to survivors, educating attorneys on trauma-informed best practices, and advocating for more survivor-centered legal systems.

30 survivors were provided over **32** hours of free legal consultations during virtual office hours

767.5 hours of free legal service saving survivors **\$208,295** worth of legal work

12 survivors were provided legal representation by VOCA-Funded Panel Attorneys

23 hours of legal training provided to other professionals

18 clients represented for long-term representation



MEANINGFUL ACCESS HOUSING PROGRAM

Since our short-term housing program launched three years ago, it has developed in such a thoughtful, survivor-centered way, housed survivors and promoted healing, and gained national spotlight as a best-practice model. In 2025, we wrapped up the first cycle of our Transitional Housing program, providing longer-term support for survivors. OAESV also provided items for basic needs and school supplies, as well as stopgap food assistance during the government shut down.



OAESV's Meaningful Access Housing Program is also being sought out for national technical assistance.

We published an evaluation report on our program, showing the need and efficacy of sexual violence housing services in Ohio.

OAESV POLICY & ADVOCACY YEAR IN REVIEW

In 2025, OAESV strengthened survivor-centered policy, protected critical funding for rape crisis programs, and elevated survivor voices at the Statehouse and within statewide systems.

Our Annual Advocacy Day brings together community members from across Ohio to collectively advocate for survivors. In 2025, we had **357** attendees, held **93** legislative meetings, and welcomed **9** inspiring speakers.

Key Priorities Advanced

- Secured continued funding for rape crisis centers in Ohio at \$15 million per fiscal year in the Ohio Operating Budget.
- Advanced legislation strengthening survivor rights and access to services.
- Opposed harmful bills that would increase barriers to reporting or reduce prevention capacity.

Strengthening Statewide Coalitions & Elevating Survivor Voices

OAESV worked with rape crisis centers, state agencies, legislators, universities, legal advocates, and survivor leaders to advance shared policy goals.

785 advocates & allies trained in policy and systems advocacy

OAESV also ensured survivors were centered in all advocacy efforts. The public policy team engaged survivors throughout the state for survivor-informed policy analysis of the bills we tracked. We also uplifted lived experience experts in testimony, briefings, and coalition work.

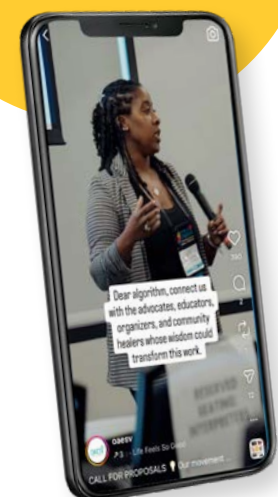

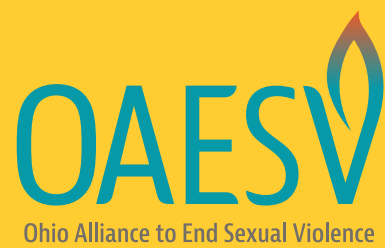
